#### **Building Safety Fund Application**

Dear Leaseholder,

We were due to give a formal update to you by the end of last week, so please accept my apologies for the delay. While drafting the update with the content we originally wanted to share, there was a change in circumstances with the development's project, which meant we had to redraft our original newsletter.

We can now confirm that the Building Safety Fund (BSF) has approved our benchmarking and that the project in its entirety has been put forward to Funding Approval Board, where recently funding was approved!

This now means that the fund will begin to issue the legal paperwork to the freeholder and project team for signing. We have been advised that this process can take multiple weeks, but we have asked to be completed at haste.

The project team recently met with the freeholder and their solicitors, where the solicitors identified several issues with the current drafting of the Grant Funding Agreement. As you know, ARMA previously negotiated a new Funding Agreement. All project risks were laid out by LIV, and all legal risks were laid out by the freeholder's solicitors. I am happy to say that the freeholder felt it was best to move ahead with pace and secure the funding and begin works.

I can therefore confirm all documentations have now been issued for final signature, and we expect them to be returned by all parties in the next few days. Shortly, we will be writing to all leaseholders, via correspondence addresses, to invite you to meet with us to discuss the project further. We will also send letters to residents explaining the works that will take place.

This is an extremely positive step for the development and stands by our commitment to get a fully funded project for leaseholders – something we have now achieved. I know this process has been a long and arduous one, and I would like to thank all leaseholders for their continued patience and support throughout.
